

Fitness for Work and Work Capacity Assessments

Our fitness for work assessments provide recommendations to assist employers in determining an employee's functional capacity to perform their role safely and their ability to return to work following an injury or illness.

Our assessments comprise a full consultation with a Medical Practitioner or Occupational Physician, and when required, a physical assessment is conducted to assist Doctors in determining an employee's functional capacity to perform their role.

Our Specialists can also conduct non-face-to-face medico-legal assessments such as file reviews and medical opinions.

Independent Medical Examinations

An Independent Medical Examination (IME) can assist throughout a claim to provide the appropriate treatment recommendations, liability or current capacity.

Unlike some providers, our Doctors will conduct a phone consultation with the Case Manager prior to the IME to gain a better understanding of the purpose/s of the assessment so we can provide accurate advice and appropriate treatment solutions.

Our approved Medical Specialists complete permanent impairment assessments using the *AMS 5th Edition under the WorkCover WA and NSW Guides*.
